
E-Verify Integration

E-Verify is a web-based system operated by the U.S. Department of Homeland Security, in partnership with the Social Security Administration. E-Verify allows employers to electronically verify an employee's eligibility to work in the United States. UKG Ready integrates with E-Verify to make it faster and easier for you to utilize this government service, while also improving the consistency of processes and verifications, legality, recordkeeping and more.
